_Purpose of the Václav Havel Library

The Václav Havel Library was founded on 26th July 2004 by Dagmar Havlová, Karel Schwarzenberg and Miloslav Petrusek, according to the model of American presidential libraries, not only as a site for the documentation, examination and dissemination of the life and work of Václav Havel, but also as a centre of the "Havel-type spiritual world" – a venue for reflection on modern Czech history as well as on the role and position of the Czech Republic in a globalised world, with an emphasis on the themes of Freedom, Human Rights and Human Creativity. The Václav Havel Library is a non-governmental, non-profit organisation which is listed on the Register of Public Benefit Companies, administered by the Municipal Court in Prague in Section O, file number 338.

_Activities of the Václav Havel Library in 2010

PUBLIC AND CLUB EVENTS

Events organised by the Library were held in the same venue to which the provisional Václav Havel exhibition was moved — the premises of the Montmartre Gallery in Řetězová Street in Prague's Old Town. This venue allows for the combination of the exhibition on the life and work of Václav Havel with temporary exhibitions, events across a broad spectrum of genres (workshops and colloquia, lectures, smaller theatrical performances, etc.), educational programmes for young people and even complementary sales. The Montmartre Gallery thus also serves as a "laboratory" where the limits and possibilities for the future permanent seat of the Library are being verified.

In 2010, most of the events in the Montmartre Gallery were concentrated in two thematic cycles mapping two creative stages in life of Václav Havel: *Spring with the 36ers* and *Autumn with Kampademie*. The cycles were composed to include both the public club activity of VHL and also its exhibition and editorial activity.

_"Spring with the 36ers" | January - May 2010

The Šestatřicátníci (those born in 1936, or the "36ers") association was the first literary and artistic group which Václav Havel put together at the beginning of his career, in the years 1953-1954, as a seventeen year old - and the association shaped his own creative beginnings. In addition to Václav Havel, a number of writers and journalists emerged from the group, among them especially four authors who were extremely important for the history of Czech culture - Jiří Kuběna, Josef Topol, Věra Linhartová and Viola Fischerová. It was therefore appropriate to recall the "first fruit" of Havel's literary and organisational activities, to bring the authors together again and present them to a wider audience. "Spring with the 36ers" consisted of several interrelated cultural achievements:

The Cycle of five literary evenings

The cycle recalled the work of the five most outstanding authors of the group, five nonconformist teenagers of the 1950s: Jiří Kuběna, Viola Fischerová, Josef Topol, Věra Linhartová and finally the texts of Václav Havel himself.

_The Exhibition of art work of Jiří Kuběna, "Masks, Drawings and Paintings"

Jiří Kuběna is an artist in two fields, literature and fine art. However, his art work (paintings, sketches) has never been exhibited publicly in the Czech Republic, as it stands in contrast with contemporary art trends. The exhibition catalogue was published as the first volume of the second year of the Václav Havel Library Workbooks.

_Discussions 36ers: May 2010

Reissue of the manuscript magazine from the 1950s, the first "samizdat" of Václav Havel and his friends. Programme considerations, poems, criticism. First texts of Václav Havel and Jiří Kuběna. In the years when official Czech writers mourned Stalin's death, what did these adolescents write? Published as the second volume of the second year of the Václav Havel Library Workbooks.

The Exhibition of poet Jiří Kuběna opens the cycle Spring with the 36ers

Prague, 13th January (ČTK) – The exhibition of oil paintings and sketches by the poet Jiří Kuběna will, until 31st May, be the first event of the cycle Havel's first gang, or Spring with the 36ers in the Václav Havel Library in Prague. The cycle will recall the first artistic fellowship which ex-president Havel formed around himself in the mid 1950s. Jiří Kuběna, Viola Fischerová, Josef Topol, Věra Linhartová and Václav Havel will introduce their verses over the course of five literary evenings held from February to May. "Kuběna's painting work is more than the mere dalliance of a poet," Ivo Binder, curator of the exhibition said at today's opening. He added that Kuběna, as a member of the literary and artistic group the 36ers, created his largest number of painting works in the period from 1967 to 1969 due to a "momentary scepticism regarding the written word". In addition to oil paintings and sketches, the first public exhibition of Kuběna's works of visual art also offers five colourful cardboard masks which he used years ago when reciting his verses. "I was horrified by grey, brown and all kinds of dirt," Kuběna, who is seventy-four this year, commented on his works. He also presented excerpts from his literary work to the participants. who also included ex-president Havel and TOP 09 Chairman, Karel Schwarzenberg.

Martin C. Putna, director of the Václav Havel Library, informed those attending the opening of the content of Havel's address, the text

of which will appear in the catalogue available from 2nd February.

"I believe that I can, on behalf of the entire Association of Friends of Jiří Kuběna (one of the oldest independent initiatives in the Czech Republic), express my satisfaction that Jiří Kuběna has now conquered Prague also as an artist. More than forty years ago he conquered the city (also with help of our Association) as a poet and reciter (an ugly word but is there any better way to say it?). Jiří, we congratulate you that having conquered socialist Prague you have now also conquered capitalist Prague!" Havel writes in his address. The distinguished Czech poet Jiří Kuběna, whose real name is Jiří Paukert, is an art historian by profession.

He ranks among typical representatives of the Czech literary underground, with whom the public might not be familiar. In the 1950s he cooperated with the 36ers Václav Havel and Josef Topol, published in the 1960s, after which he was not allowed to publish for a long period, and experienced the isolation of the normalisation years in samizdat. After 1989, amongst other posts, he worked as castellan of Bítov castle.

The 36ers group was formed by the then seventeen year old Václav Havel in 1953 and 1954, and provided a springboard for many writers and journalists who have been significant for the history of Czech culture.

Havel's first gang introduces itself

PRAGUE Spring season in the Václav Havel Library, which bears the title Havel's first gang, or Spring with the 36ers, will recall the first artistic fellowship which young Havel formed around himself in the mid 1950s.

The first event is today's opening of exhibition of visual art by Jiří Kuběna, Václav Havel's earliest fellow-traveller, today a renowned poet but not yet famous as a painter. The exhibition, whose curator is Ivo Binder, is open in the Montmartre Galery in Řetězová Street in Prague. Author and artist Jiří Kuběna will present excerpts from his texts at the opening.

"I believe that I can, on behalf of the entire Association of Friends of Jiří Kuběna (one of the oldest independent initiatives in the Czech Republic), express my satisfaction that Jiří Kuběna has now conquered Prague also as an artist. More than forty years ago he conquered the city (also with help of our Association) as a poet and reciter (an ugly word, but is there any better way to say it?). Jiří, we congratulate you that having conquered socialist Prague you have now also conquered capitalist Prague!" Havel writes in his salute to his friend and colleague.

Literary evenings in the dramaturgy of Zdeněk Janál were held under the names below and in the following order:

2nd February:

One more Kuběna on Groundhog Day!

Works mostly from the period of the 36ers, i.e. from the early 1950s, were read by the poet and the poet's teenage alter ego. His alter ego was represented by a drama student at the Academy of Performing Arts (DAMU), Jiří Suchý z Tábora. A literary and historical introduction to the context of Jiří Kuběna's poetry was presented by the long-term commentator on his work, Martin C. Putna. During the course of the evening a catalogue of the exhibition was also introduced, Jiří Kuběna: Masks, Drawings and Paintings, published as the first volume of the second year of the Václav Havel Library Workbooks.

24th February:

I tuned my Viola as deep as possible

Poetess Viola Fischerová gained renown for her work written—as the name of the collection suggests—in her "Old Women's Hour", from the 1990s to the present. This evening, however, presented her contemporary texts juxtaposed against her almost unknown and partially works which are now gradually being rediscovered, from the era of the 36ers. Verses were read by the poetess herself and by her younger alter ego, a student of drama at the Academy of Performing Arts (DAMU), Marie Štípková. Martin C. Putna gave the literary and historical introduction.

31st March:

Plant the Poplars tightly around the pond

Josef Topol's (topol is Czech for poplar) poetry remained within the poet's private sphere almost throughout his entire life – he was not published until the 1990s. His poetry completely shuns contemporary reality, seeking refuge in the proudly archaic and aristocratic language of the Romantic poets. It is a poetry which traces step by step the author's inner world, from teenage exaltation to feelings of darkness and hopelessness during the 1980s, where only spiritual hope stands in resistance, in spite of everything. Words such as subtlety and anxiety are constants in his poetry.

Martin C. Putna gave the literary and historical introduction. The texts were read by DAMU (Academy of Performing Arts) students Jiří Suchý z Tábora and Marie Štípková. The poet was represented by his guardian angel, Vlastimil Harapes.

21st April:

Věra Linhartová hidden behind words...

The most mysterious member of the circle of the 36ers, poetess Věra Linhartová, left for Paris at the end of the 1960s. where she pursued a career as a world-renowned orientalist – and then in the manner of poets and sages of classical Asia "retreated to the mountains", i.e. she withdrew entirely from the world to complete privacy. It was only upon an urgent plea from Václav Havel's that his old friend exceptionally opened her hermitage a little and provided her voice recording for the Václav Havel Library. Martin C. Putna brought the unique recording from Paris, introducing it at the Evening of Věra Linhartová. It contains the poetess reading samples of her texts in Czech and French, as well as excerpts from the interview Martin C. Putna conducted with her about the 36ers, Václav Havel, Richard Weiner and about her urge to "retreat to the mountains". A DAMU student, Marie Štípková, read further poetic texts. The long-time friend and interpreter of the authoress, Miloslav Topinka, gave the literary and historical introduction

2nd June:

When even Havel wrote verses

The evening of Václav Havel was the last of five presentations of the personalities and work of the most significant poets among the 36ers – an unofficial literary group born from the initiative of Václav Havel in the 1950s. The poetic texts were read by the author himself, together with his adolescent alter ego, Jiří Suchý z Tábora. Martin C. Putna gave the literary-historical introduction.

Václav Havel is a poet of everyday, civilian life, a poet of cafés and embankments. A poet of unseen America. A poet almost eclipsed by his roles as playwright, dissident, thinker and president. A poet who has survived in spite of all of this.

The evening also introduced the Václav Havel Library Workbook 2/2010, composed of works of the 36ers published in Samizdat magazines Discussions 36 and Silver Wind. Amongst other features, it contains Havel's unknown texts from his earliest period, uncovered in the depths of Hrádeček. The 36ers were truly the "First Gang", which Václav Havel gathered around himself when he and the others were seventeen years old. It was indeed "The Gang" – a quite exceptional bunch of teenagers with literary, political and philosophical ambitions, who purposefully by-passed the literary, political and philosophical currents of their time, the darkest Stalinist years. At the time Václav Havel did the same

as he would later do in the 1960s when trying to find the platform of independent creativity and thinking across movements in the Tvář magazine. And he did the same again in the 1970s, when he organized another community of independent personalities of culture, thought and politics – Charter 77. And in fact he did the same again in the 1990s when, in the face of the tendency towards complete identification of politics with a political party, he declared an "apolitical politics" – politics, the bearers of which should be integral independent personalities, for whom political affiliation (if there is any) is secondary. Even if for no other reason, for this reason it is instructive to read these earliest teenage texts of Václav Havel and the members of his "First Gang" – his "Proto-charter".

I tuned my Viola as deep as possible or literary discovery at Bítov castle

Within the Spring and the 36ers project taking place from 13th January to 30th May the Václav Havel Library presents a cycle of literary evenings documenting the "work of the five most distinctive authors, five nonconformist teenagers from the fifties" from an association founded by Václav Havel in 1953-4: Jiří Kuběna, Viola Fischerová, Věra Linhartová, Josef Topol and Václav Havel.

The program of literary evenings introduced by Martin Putna is composed as a juxtaposition of the creative beginnings of these artists with their current work. After Jiří Kuběna, on 24th February the second guest was to be poetess Viola Fischerová but it seemed that the event would have to be cancelled because her early work, as she herself was convinced, was not preserved and only fragments remained in her memory.

To the poetess's great surprise, Jiří Kuběna discovered in Bítov castle a number of her poems recorded by other persons — for example, one of them is copied down in the diaries of Jiří Kolář. It was eventually possible to hold the event, and listeners had the opportunity to hear her long-lost verses for the very first time.

Viola Fischerová is not only poetess but also her life story develops as a dramatic work. She was born in Brno in 1935 and her childhood was affected by wartime anxiety and fear, which often became a source of inspiration, similarly to her complex relationship to parents. Her father — philosopher Josef Fischer, who lived in emigration during the war, soon won her favour, at the expense of

the withdrawn mother, who was desolated by the experienced events and eventually left because of another woman.

Viola wrote her first poem at the age of 11 out of spite when her mother did not allow her to exercise in Sokol. She wanted to avenge herself with ugly words and composed a decadent poem about graves and death — without being aware of Decadence. She continued writing poems like many other young people, and when first positive responses came she had her poems evaluated by Jiří Kolář, Vladimír Holan and Jan Grossman — who was then briefly employed in the post of director of the Čs. spisovatel publishing house. Jan Grossman also asked her to assemble a collection of her poems for publishing.

However, the collection Propadání (Falling Through) turned out to be too decadent for the circumstances of the day – in 1957 – and there was no chance of publication. Nevertheless, Viola Fischerová was not daunted.

A paralyzing blow paradoxically came from a different direction, which had no connection with politics.

The blow was inflicted by the work of Věra Linhartová. Viola Fischerová regarded her work as so brilliant in comparison with her own verses that she stopped writing for almost forty years...

In 1968 she emigrated with her later husband Pavel Buksa (writer Karel Michal) to Switzerland, where she made her living in various jobs — she sold kitchenware, worked as a theatre assistant of director Dügelin, she was in touch with Friedrich Dürrenmatt, studied Germanics and History in Basel and taught at an apprentice school.

When her husband Pavel Buksa committed suicide in 1984, she moved to be with her friend and later husband Josef Jedlička to Munich and co-operated with Radio Free Europe and Svědectví magazine there.

Viola Fischerová evidently felt a need to express the trauma of her husband's death. As she recalls, she had a vision when travelling to her husband's grave in Basel which first grew into several lines, then poems and finally into Zádušní písně za Pavla Buksu (Requiem for Pavel Buksa), which was published in 1993. It was as if a barrier had been broken and after that time she published one collection after another.

At the beginning of the 1990s, after the death of her second husband, she returned to Prague and in 1995 published collection Babí hodina (Old Women's Hour) in which she is fascinated by old age, old women and their dreams of young men. In 1996 for example collection Odrostlá blízkost (Grown Proximity) was published, followed by the collections Divoká dráha domovů (Wild Track of Homes) in 1998, Matečná samota (Mother Solitude) in 2002 and Nyní (Now) in 2004 which in translation won the prestigious German

literary prize – Dresden Poetry Prize in 2006. In the same year Viola Fischerová won the Magnesia Litera prize for the book of fairy tales, Co vyprávěla dlouhá chvíle (What the Boredom Told) as the best book for children and youth.

Her last published work to date is Domek na vinici (House in the Vineyard) from last year and further poems, whose verses those attending the literary evening could hear recited by the author, are being prepared for publication.

Václav Havel reads his early verses and concludes Spring with the 36ers

Prague 2nd June (ČTK) – Tonight, ex-president, dramatist and writer Václav Havel concluded the literary cycle of events, Spring with the 36ers, by reading texts from his youth. In the seat of the Václav Havel Library in the Montmartre Gallery in Prague he was watched by a room overcrowded especially with young people.

"The author has never read his own verses aloud, let alone verses half a century old," director of the library Martin Putna pointed out in the introduction.

"I firmly believe that this shall also be the last time that I read these verses aloud," Havel said. He reputedly agreed to this idea injudiciously and the closer the date approached, the more he dreaded it. He then read the first poem, adding that everyone would understand why as a teenager he soon stopped writing poetry and resorted to other forms.

"They displayed banalities, which the author then believed were an inevitable part of youth," said Havel, who in his creation often used terms such as 'silver'. "But also 'green', as evidence of who I support," the former president stated in reference to the recent elections, entertaining the audience as well as himself. He read the juvenile texts himself, accompanied by his adolescent alter ego Jiří Suchý z Tábora who gently guided him during the reading.

In total, Václav Havel wrote four collections of lyrics, which remained in manuscripts.

"They show that the formation of a personality can be complete already at seventeen years of age," Putna said in summary of the collections.

During the meeting "graphic poetry" was also heard, which, as it transpired, only seemingly cannot be recited, much to the amusement of the audience.

The literary evening entitled When even Havel wrote verses was the last of five presentations of the personalities and work of the most significant poets from the ranks of the informal literary group established upon Havel's initiative in the 1950s. It also included an introduction of this year's second volume of the Václav Havel

Library Workbooks, compiled from the works of the 36ers published in samizdat magazines Discussions 36 and Silver Wind. In the publication, there are also some unknown texts from Havel's earliest period, freshly discovered at Hrádeček.

The 36ers were truly the "first gang" which Václav Havel gathered around himself when he and the others were seventeen years old. "It was indeed quite an exceptional gang – a bunch of teenagers with literary, political and philosophical ambitions which purposefully by-passed the literary, political and philosophical currents of their time, the darkest Stalinist years," Putna wrote in the introduction to the book. In his opinion, Havel did the same as he would later do in the 1960s when trying to find the platform of independent creativity and thinking across movements in the Tvář magazine. Likewise, in the 1970s he organized another community of independent personalities of culture, thought and politics in Charter 77. And in the 1990s, in the face of the tendency towards complete identification of politics with a political party, he declared an "apolitical politics"; the bearers of which should be integral independent personalities, for whom political affiliation is secondary.

The Václav Havel Library was created according to the model of US presidential libraries. It is the only institution of its kind in Europe and serves for the documentation, examination and propagation of the life, work and ideas of Václav Havel, the playwright, freedom fighter, organizer of Czech and Central-European independent culture, prisoner of conscience, leader of the 1989 Velvet Revolution, Czechoslovak and Czech president and one of the world's moral authorities of the 20th century.

_"Autumn with Kampademie" October - December 2010

The central theme of the Autumn season in the Václav Havel Library was Kampademie – an unofficial "underground" academy with its seat on the Prague island of Kampa, whose environment considerably influenced Václav Havel's thinking especially in the 1970s and 80s.

5th October Opening of exhibition

"Plato in Kampa - LOTR in Hrádeček"

The ceremonial opening of exhibition, outlining in contemporary documents the unique intellectual fellowship – Kampademie – a renewed Platonic academy with its headquarters on the Prague island of Kampa.

The intellectual and physical space where in 1970s and 80s

Václav Havel's interests intersected with diverse philosophical themes, playfulness and admiration of *Lord of the Rings*. A school whose students and at the same time teachers were Tomáš Halík (*Gandalf*), Radim Palouš (*Elrond*), Martin Palouš (*Sam*), Daniel Kroupa (*Frodo*), Pavel Bratinka (*Gimli*), Helena Webrová (*Mulier*) and Ivan M. Havel (*Puzuk*).

8th October

Kampademic colloquium

The afternoon part of the program was the **first public meeting of Kampademie**. Director of the library Martin C. Putna gave an introduction, Radim Palouš presented the main contribution. A discussion of the Kampademics followed, with active participation especially from the student section of the audience.

The evening program was devoted to the festive launch of the Václav Havel Library Workbook 2010/3: *Zdeněk Neubauer/Consolatio philosophiae hodierna* and the first volume of the Václav Havel Library Edition – *Fausting withHavel*.

Exhibition and anthology recall the work of the Kampademie fellowship

Prague, 8th October (ČTK) — Starting today, the exhibition of photographs and other materials entitled Plato in Kampa, LOTR in Hrádeček in the Václav Havel Library in Prague recalls the work of the Kampademie intellectual community. Philosophers, scientists and dissidents such as the later rector of the Charles University, Radim Palouš, priest Tomáš Halík, politicians Pavel Bratinka and Daniel Kroupa, or the ex-president's brother Ivan Martin Havel met for discussions in their own flats or at Havel's cottage in Hrádeček, in 1970s and 80s. Their work is also recalled in the anthology of texts, Fausting with Havel.

The future president also wrote from prison some of his philosophical letters to members of the group, known under name Letters to Olga and sent to his first wife. "Kampademie was an unofficial philosophical association. Václav Havel was its cooperating member. It significantly influenced his thinking," the director of the Václav Havel Library Martin Putna told ČTK. Some of the members of the association, including the president's brother Ivan, met in the library this afternoon to recall the activity of the association. However, Václav Havel himself did not attend.

The anthology Fausting with Havel was originally prepared by

members of Kampademie for Havel's 50th birthday and refers to the Faust-type archetype, that is the motif which the playwright utilized in his then play. Pokoušení (Temptation).

Also the book of philosopher Zdeněk Neubauer, Consolatio Philosophiae Hodierna, the first interpretation of Letters to Olga, was reintroduced today. "Václav Havel, whilst still in prison, sent a message through a messenger to Zdeněk Neubauer asking for his opinion," Putna explained. By coincidence, this messenger was today's Archbishop of Prague, Dominik Duka.

However, the exhibition also documents the humour of the group members who gave themselves nicknames based on the book Lord of the Rings (LOTR) by the British writer J.R.R. Tolkien. "They took Tolkien as a metaphor for their own fight with the regime," Putna explained. Moreover, Kampademie members labeled the policemen quarding them at Hrádeček cottage "Orcs".

1 st December Letters from Olga

Olga's letters were written by Ivan Havel

Almost thirty years after Havel's Letters to Olga blazed their trail in samizdat, next week the Letters from Olga shall be published for the first time in book form. However, the prisoner's brother plays a more important role in the letters than his wife.

The Letters from Olga are not an easily digestible read in many places – going into depth on the themes of quantum mechanics, meta-experience, logical paradoxes, as well as Bach's fugues.

It is a crazy correspondence puzzle from the times of the normalization prison system.

Although Václav Havel wrote Letters to Olga when in police custody in Ruzyně prison (1979), and during his punishment in Heřmanice and in Bory (1980 to February 1983), more intensively than with his wife he conducted discussions with his brother Ivan and the philosopher Zdeněk Neubauer. Perhaps nobody will be surprised then that Letters from Olga were not actually written by Olga.

Letters lost forever?

It gets even more complicated. Although Olga also wrote to Václav, her letters were lost somewhere. Václav Havel was allowed to keep only new correspondence from home and had to give the older letters to the prison administration. Although the prison administration returned the mail to the addressee after his release, that which survived prison did not survive the presidential era — or rather Havel's series of relocations.

"The fate of Olga's letters is highly uncertain. We would be grateful for any mention of them, though with regard to their content, those written by Ivan are more important," says the director of the Václav Havel Library, literary historian Martin C. Putna, who initiated the book Letters from Olga. He thus hints that Olga wrote "little, briefly and only on practical matters." Václav often chided her to answer more often, in more detail and greater volume. And if possible, in a more literary style.

"I do not hide that my rather disagreeable pedantry is somewhat affronted by their obfuscating telegraphic style, their lack of rigorousness and compositional logic and considerable syntactic, grammatical and graphic carelessness," he assessed his wife's letters a little indiscriminately.

The addressing is of no importance

On the contrary, very elaborate texts were sent to him to prison by his brother Ivan, a respected scientist who also inspired Havel to invent the artificial language ptydepe in the play Vyrozumění (The Memorandum). According to Putna, Ivan was the concealed addressee of the letters, a partner in a "dialogue between brothers, a truly philosophical dialogue from prison to prison."

The reader is misled by names of both Letters to Olga and Letters from Olga, but at least consistently. They are in the spirit of Czech correspondence literature, Čapek's letters to Olga, Kafka's letters to Milena.

In addition, Havel already in prison apparently stylized his letters with regard to their possible publishing, composed them as an original literary work in which the addressing was of no importance.

Ivan's letters, condensed excerpts from current reading, references to movies (from Autumn Sonata up to the Alien) as well as interviews, with long philosophical and physical considerations, or quoted poems, intermediated "the world behind the wall", however limited.

Political witch hunts, house searches, campaign of Rudé právo newspapers or reports about imprisoned friends flickered there in encrypted form. When Ivan Havel passed greetings from Kamila (Bendová) and mentioned that her husband "reputedly besides playing chess also teaches logic," it meant that Václav Benda in prison had the opportunity to play chess and intended to practice lectures on logic. Or another example: "children's playground" for example in the fraternal parlance indicated the venue from which prisoners could communicate with their surroundings.

Of course, also purely personal events intruded into the exchange of correspondence, in particular Havel's health problems and the death of his father. While in the first letter from June 1979 Ivan reported that the father is "a bit sick", in early August it was already after the funeral.

The farewell to the legendary creator of the Barrandov district and co-owner of Lucerna Palace had a symbolic meaning — probably this is why the State Police did not allow the national anthem Where is my Home to be performed there. The theme of the funeral returned once more in the letters, through the samizdat book of Ludvík Vaculík, Český snář (The Czech Dreambook) which enchanted Ivan and he quoted from the book in detail.

"Hopefully my review will enable you to orient yourself better within your own thoughts. Olga and I are very interested in your contemplations and the circumstances in which they are written—although we do not wish them on you—can be considered extremely important for their persuasiveness and weight (not to mention their existence)," wrote Ivan, who tried hard to prevent his brother's "mental atrophy". He also reported in detail on reviews of the Viennese staging of Havel's play Horský hotel (Mountain Hotel). Among the enthusiastic reviews he included also a scathing one, which condemned the work as a "hard massage of boredom", evidently believing that Havel was protected by an armor of high self esteem at that time.

He was not - and in future Ivan was not allowed to include negative reviews in his letters.

Although Letters from Olga are not an easily digestible read in many places – going into depth on the themes of quantum mechanics, meta-experience, logical paradoxes, as well as Bach's fugues, they also convey a telling message about Czechoslovak dissent and the circle of Havel's friends, acquaintances and intellectual kindred spirits.

In this respect, the "prisoner" had a special position: Anna Šabatová interpreted her mother's advice about the elbow complaint from which he suffered, Radim Palouš wrote about God and the meaning of history.

Fundamental cheat sheets from a philosopher

Approximately half way through the correspondence, and in fact by accident, a new — and as it turns out pivotal — "voice" of the renowned philosopher Zdeněk Neubauer appears. Ivan Havel gave him some of Václav's letters to read, asking whether he could

insert some comments and give him advice regarding the more demanding passages.

"Well, I, suspecting nothing bad, wrote a bunch of barbed and flippant comments under the impression that Ivan was really beating his brains what wisdom he could write to his brother in prison," Neubauer recalled in an interview with M. C. Putna. He considered his impudent comments to be kind of "cheat sheets for Ivan", however, Ivan took them without any adjusting and polishing, copied them verbatim and sent them to his brother — who had a mental breakdown. Neubauer's comments caused Václav Havel to feel doubts and "total disgust" regarding his own letters: "They suddenly began to appear to me as an incredible spewing of banalities."

But Neubauer did not mean it so resolutely: "Poor Vašek in prison pours out something like this, something very authentic, and now he receives such heavy criticism of it, which he reads in isolation and out of context."

Fortunately, Havel soon shrugged off his melancholy and started responding to Neubauer's stimuli in his own way. An intense, deep exchange about human existence, responsibilities, experience, resignation, free will and faith thus developed. Howsoever they do not always correspond with each other, this spiritual melody forms the core of not only the Letters to Olga, but also those from "Olga".

Havel wrote to Olga, Olga writes to Havel

Prague — Václav Havel Library officially unveiled the first publication of Letters from Olga, replies to letters written by dissident Havel from prison at the turn of the seventies and eighties at Prague's Montmartre Gallery. These are not only descriptions of life behind bars, but also cover major social and philosophical reflections on Havel's ideas. The correspondence was published collectively under the title Letters to Olga, though most of these letters were not intended directly for his wife. Besides, the author of the texts from the book launched today mostly is not Olga Havlová, but in particular Ivan M. Havel, the ex-president's brother.

Václav Havel wrote letters from police custody in Ruzyně and from prisons in Heřmanice and Bory in Plzeň from June 1979 to September 1982. He was sentenced in 1978 to four and a half years of imprisonment for subversion and released in 1983 on the grounds of poor health. After his release he compiled the letters into book form, in co-operation with the literary critic and signatory of Charter 77, Jan Lopatka. The Letters to Olga were published for the first time in 1983 in an edition of the samizdat Expedice, established by Havel in the mid 1970s.

Havel addressed the letters from prison to his wife, but she often read them aloud also to their friends. It is possible to read them also on the website of the Václav Havel Library, including those that were not printed in book form. What Olga wrote to Havel was not known – her replies were seized by the State Police during a house search and were reportedly lost.

An account of the era

The collection of Letters from Olga consists mainly of texts by Ivan M. Havel. In the correspondence with his brother, in spite of obstacles of the prison censorship, he also included other authors, in particular the philosopher Zdeněk Neubauer, the main commentator of Havel's reflections on ethics, responsibility, and the absolute horizon. Consciously or unconsciously, also Radim Palouš, Petr Hájek, Anna Šabatová, Jiří Dienstbier, Martin Heidegger, Emmanuel Levinas, Raymond Ruyer and Vladimir Holan featured in the replies.

The initiative to publish the "Letters to Václav" came from the director of the Václav Havel Library, Martin C. Putna.

"They will reveal that Václav Havel was not a solitary thinker, but that what he wrote in Letters to Olga corresponds to then philosophical thinking of Czech dissent, which represented precisely the circle of which Ivan Havel was a member and whose key personalities were Radim Palouš and especially Zdeněk Neubauer. Today's Czech intellectual elite feeds largely on what originated at that time," believes Putna.

Martin C. Putna: The whole world knows the book Letters to Olga as a philosophical treatise on ethics, responsibility, individual freedom and basic philosophical and religious topics. Letters from Olga is the response, the other side, the second voice in the dialogue. Those who read Letters to Olga and wish to learn more about the context and mode of thought will find that this book is precisely for them. Whoever overcomes the obstacles presented by this sometimes very difficult text will learn a great deal about Czech thought.

Ivan M. Havel: "For today's reader the book might be an interesting document of the time. We in fact also were in a kind of small prison, it is a different environment, different atmosphere, but there are some limitations; we were, we can say, in a ghetto."

He also came up with the idea to call the book Letters from Olga, although the authors of the letters were other people. "It was a kind of division of labour. Olga rather wrote about more personal matters, and I realised that Václav in prison needed to have more intellectual material for reflection," Havel's brother Ivan, the cyberneticist and philosopher, added. However, unlike the ex-president, he did not reckon with publication of his texts.

"The book is extremely heavy..."

Havel himself reputedly saw Letters from Olga for the first time at today's launch of the book. "I was shocked by its size," he admitted. "We were always allowed to keep only one letter from home, and when we received a new letter we had to hand in the previous one." He intended to publish only the meditative massages in Letters to Olga, however, the then editor Jan Lopatka persuaded him that they should be published unabbreviated, including writing on practical concerns. The editors of Letters from Olga kept to this method. "We did not make any adjustments in the texts, except for linguistic adjustment of a slightly more creative letter from Zdeněk Neubauer. We tried to reconstruct the course of the correspondence because due to the prison censorship not everything got to the addressees," the book's editor Jan M. Heller clarified.

The Letters from Olga therefore represent a hitherto missing voice of conversations the imprisoned Václav Havel had with his loved ones. They will become the subject of examination of historians as well as students. Eyewitnesses need not recall the era in question so thoroughly, as evidenced by the words of art historian Věra Jirousová, the first wife of Ivan "Magor" Jirous: "I will certainly read Zdeněk Neubauer, because I have not yet had his texts to hand. Whether I'll read everything I do not know, maybe if there's a really long winter, but I have an awful lot ahead of me and the book is awfully thick…"

Ruml joins Green Party, Havel and Hanák declare support 16th March 2010 tyden.cz

The Greens go to the parliamentary elections with a strong wind at their backs. On Tuesday, they were publicly supported by a number of significant personalities led by Václav Havel, the supporters include also writer Michal Viewegh and singer Lenka Dusilová.

Nearly forty people have already signed the text We vote Green, written by the sympathizers of the party, which at the moment is struggling with a share of the vote at under the five percent eligibility limit. Former leader of the Freedom Union and Interior Minister Jan Ruml has also joined the Green Party. "I submitted my application in Prague 2" he said.

Havel: I have been green since time immemorial

Václav Havel added yet another reason why he believes in voting Green. "The Greens are a spark of hope for all who feel disillusioned with public life. I believe that the Green Party will not disappoint these hopes.

The former president jokingly repeated that he had always been green. "I was green even before Bursík and Liška were born. I dislike the way we treat our country, our landscape, how human settlement proceeds without any conception. And not only because of nature, but also for aesthetic reasons," said Havel.

Amálie No. 84 - Green Phoenix

On 17^{th} June 2010 the Václav Havel Library organised a discussion meeting, Amálie on the theme of "Green Phoenix".

The tradition of non-public discussion meetings, Amálie, was established by president Václav Havel. The Amálie shooting lodge at the Lány Chateau has regularly hosted meetings of politicians, intellectuals and personalities in public life, always on a set topical theme. After Havel departed from the post of president, the Václav Havel Library took charge of organising Amálie. The event now takes place in the Library headquarters at the Montmartre Gallery.

Amálie on the theme of "Green Phoenix" or "The future of the green current in Czech politics" took place on 17th June 2010. Approximately twenty personalities – journalists, activists from non-governmental organisations as well as politicians – participated in the event. Václav Havel himself has supported the Green Party in several previous elections. He even remarked, while recently reading from his adolescent poetry at the event "Spring with the 36ers", that he "had always been green."

VHL continued publishing the quarterly Václav Havel Library Workbooks, which continuously present to the public the results of the archive and the research efforts of the Library and its co-workers:

VHL Workbooks 2010/1:

Jiří Kuběna – Masks, Drawings and Paintings

The first volume of the second year of the Václav Havel Library Workbooks is a catalogue of the art exhibition of Jiří Kuběna bearing the same name.

Amongst other features the volume also includes several poems composed by Jiří Kolář, Jiří Kuběna and Václav Havel. Jiří Kuběna is also the author of a detailed calendar which charts his relationship towards the visual arts, but also the history of meeting his friend Václav Havel and the other 36ers – the group of teenagers around the young Havel.

VHL Workbooks 2010/2:

Discussions 36 and Silver Wind

The workbook is composed of works of the 36ers published in the samizdat magazines *Discussions 36* and *Silver Wind*. Amongst other features it contains Havel's unknown texts from his earliest period, uncovered in the depths of Hrádeček.

VHL Workbooks 2010/3:

Zdeněk Neubauer – Consolatio Philosophiae Hodierna

This Czech-English workbook contains an essay on the *Letters to Olga* written by Zdeněk Neubauer upon the request of then imprisoned author. The publication also includes a contemporary interview with the author about a midsummer trip, Kampademie, letters from prison and letters to prison, on Consolatio philosophiae, Hrádeček, and also about Catholicism, hallucinogenic mushrooms as well as Tolkien...

VHL Workbook No. 4/2010:

Daniel Kroupa - History of Kampademie

The first comprehensive summary of the history of intellectual fellowship of Kampademie – the renewed Platonic academy at Kampa whose members have featured, among others, Zdeněk Neubauer, Radim Palouš, Pavel Bratinka, Daniel Kroupa and also Václav Havel. The publication includes also contemporary photographs from Hrádeček and a transcript of one of the recorded Kampademie discussions.

The publication of a second, bound series has also been initiated under name *VHL Edition*, which shall include more comprehensive and serious works, whether editorially documentary or original, written for this book series. Two volumes of *VHL Edition* were published in 2010:

Fausting with Havel: An anthology of texts from 1986, in which members of the Kampademie philosophical association responded to Havel's play *Pokoušení* (Temptation). The anthology includes works by Ivan M. Havel, Radim Palouš, Martin Palouš, Daniel Kroupa, Pavel Bratinka, Helena Webrová and Zdeněk Neubauer. As a supplement, a transcription of an interview of the Kampademics with Václav Havel was also issued. So far published only as samizdat in an edition of *Expedice*.

Letters from Olga: A collection of letters sent to Václav Havel in prison during the period from 1981 to 1983. The majority of the letters were sent by Ivan M. Havel, in whose editorship the Kampademie philosophical association elaborated replies to Havel's letters. This file of letters sent to prison and remaining in manuscript form is the hitherto unknown "second half" of the world-famous *Letters to Olga*.

Other titles have also been prepared in the VHL Edition to be published in 2011, in particular:

Martin C. Putna: Václav Havel. Spiritual portrait within the framework of Czech culture of the 20th century

Václav Havel: Talks from Lány I

The Educational program "Critical Thinking Workshop" for high school students is still being held in the exhibition premises. Within the program lecturer Nina Rutová uses excerpts from texts by Václav Havel, and exhibited artefacts as incentives for students to reflect individually on the theme of freedom, totalitarianism and individual responsibility. The scenario is based on the objectives of the Framework Educational Programs for elementary and secondary schools. meets the expected outcomes of social sciences (history, literary education, civic education) monitors the benefits of cross-sectional themes (education of democratic citizens, personal and social education, education in a European and global context, media education). Nina Rutová's book Havel in a Nutshell, intended primarily as a methodological tool for high schools and prepared for publication release in 2011, also originated from this project.

ARCHIVING ACTIVITY

Digital archive of the Václav Havel Library publishes Talks from Lány

Prague 15th June (ČTK) — A complete audio recording of Talks from Lány broadcast by the Czechoslovak and Czech Radio in years 1990 to 2000 has been made available on the website of the Václav Havel Library, library director Martin Putna informed ČTK today.

The program, in which Václav Havel as president regularly commented on events in the country, changed its name slightly over the years. The Talks from Lany gradually became Talks and eventually Talks in Lány. "The last named featured, in addition to Václav Havel, also other personalities such as Václav Klaus, Miloš Zeman, Jan Švejnar, Pavel Tigrid, Jakub Patočka and Petr Pithart," informed Putna.

In total, he said, the recordings cover 335 programs with a length of over 115 hours, all of which can be downloaded free as mp3 files.

According to the former director of Czech Radio, Vlastimil Ježek, there are few personalities upon whom it is possible to build such a type of program. "Nothing like this continued after Václav Havel," Ježek recalled in a press release. He managed Czech Radio from 1993 to 1999.

"Sometime during the middle of that period, Václav Havel came up with an idea that the format of the Talks should change. Two people interviewing one man were then joined by guests chosen by Václav Havel. Instead of just responding to questions, he also started to ask," said Ježek.

The Václav Havel Library was established according to the model of the presidential libraries in the U.S. and is the only institution of its kind in Europe.

MARKETING, PUBLIC RELATIONS AND BUSINESS ACTIVITIES

Marketing activities of 2010 – in contrast to the previous year, which had to be devoted especially to the unification of the visual influence of the Library – focused on **consolidating its** "**brand**", not only in the public awareness but also in the academic world. For this purpose, for example, cooperation was established with the Institute of Contemporary History, the Nation's Memory Institute of Slovakia or the Czechoslovak Documentation Centre.

Publishing of occasional publications continued also this year, providing information on current events (exhibition poster, invitations, quarterly program folders, programs). In connection with the presentation of the central themes of spring and autumn – the 36ers and Kampademie – CLV showcases were also utilised in the vestibule of the Metro station at Staroměstská. Adjust Art PRO once again secured their provision, as well as the distribution of quarterly program folders to libraries, cafes, theatres and schools.

More intensive editorial activity resulted in a significant increase in revenues: in 2009 with 5 titles on offer the revenue generated was CZK 75 358, whilst in 2010 the Library offered 10 publications and total revenue reached CZK 181 135. These statistics clearly confirmed the presumption that there will be a large interest in publications produced by the Václav Havel Library.

Throughout the year the events of the Library were promoted also by means of **printed advertising** (for example in *Rodina a škola, Kritické myšlení*) and **announcements** (ČT, ČT24, ČRo).

The fact that activities of the Václav Havel Library gained popularity is evidenced also by the **profile of the Library on the Facebook** (on 31st December 2009 it had approximately 300 fans, one year later this number had risen to over 3 000).

LIBRARY HEADQUARTERS

Preparations have commenced for the reconstruction of a building in Loretánská Street, which is to become the definitive seat of VHL. Negotiations with Jan Koblasa – sculptor and artist connected with Václav Havel since the 1960s and respected worldwide – began concerning the basic visual allocation of the exhibition, which should present not only work of Václav Havel but also the traditions of the Czech presidency and Czech independent culture of the 20th century.

Billionaire Zdeněk Bakala has purchased a building in Hradčany where the Václav Havel Library will have its seat.

This information has been confirmed by an excerpt from real estate register as well as by the library director, Martin C. Putna.

Among others, the wife of president Edvard Beneš lived in the house on Loretánské Square. Bakala is the chairman of the Board of Trustees of the Library.

"Yes, the location is already determined. The reconstruction should take approximately a year, a year and a half," stated literary theorist and director of the library Putna. According to his spokeswoman Sabina Tančevová, ex-president Havel, who is currently outside of Prague directing the film Odcházení (Leaving) based to his own theatre play, has also viewed the building.

"He is happy that the new and permanent location for the library has now been determined and that it is in an excellent locality," added Tančevová.

Before the elections Bakala sponsored all three parties of the current governing coalition. He is also the co-producer of the film currently being directed by the former president. He is one of the co-founders of the discussion association Lípa which is sometimes labelled as a circle of Hayel's admirers.

According to its website, the Václav Havel Library, established according to model of presidential libraries in the U.S., aims to document, research and promote the life, works and ideas of the former Czechoslovak and Czech president. It collects various records relating to this politician, playwright and formerly important dissident. Various discussion sessions are also organised in the library. The institution has not yet a permanent location; for example, according to media sources a number of years ago it negotiated with the Ministry of Culture regarding the use of its building in Liliová Street in Prague, where the National Heritage Institute resides.

However, the project, which was then gaining "specific contours" was eventually cancelled despite the fact that the building is located near St. Anne's Church in the Old Town, where the Dagmar and Václav Havel Foundation VIZE 97 established an "international spiritual centre", the Prague Crossroads.

The two-storey, originally Renaissance building known as U Drahomířina sloupu (By Drahomíra's column) was named after the column which originally stood in front of the house until 1788 and which depicted the destiny of St Wenceslas' mother. The Černín family, and later count František Josef Šlik, were the owners of the house.

2. The fundamental accounting policies applied by the company

(a) The method of processing the accounting records and the method and place of their storage

External company Ducháček&Abrt, spol.s r.o. keeps accounting. Company books are processed in the FOFRS economic system.

(b) Fixed tangible assets

Fixed tangible and intangible assets are recorded at their acquisition price. Fixed tangible assets with the acquisition price of up to CZK 40 thousand and fixed intangible assets with the acquisition price of up to CZK 60 thousand are not recorded in the balance sheet and are charged to expenses in the year of acquisition.

(c) The conversion of foreign currencies

When converting foreign currencies, the company uses the Czech National Bank's daily exchange rate valid on the day of the clearance of the transaction. Only realised exchange rate gains and losses are entered in books in the course of the year.

Assets and liabilities in foreign currencies are converted as of the balance sheet day according to the exchange rate on the foreign exchange market published by the Czech National Bank. Unrealised foreign exchange gains and losses are recorded in the balance sheet.

(d) Inventory

The finished products (books) include material, wages and other direct costs.

The goods are valued at the acquisition prices. The acquisition price includes the price of acquisition and any secondary acquisition costs (e.g. transport).

Books purchased for the purpose of activity of the Archive of the Library are entered in the account of balance sheet and charged to expenses for the time of 5 years.

(e) Received and provided gifts

Company keeps account of the financial means received on the basis of a deed of gift to account Funds, from which these received financial means, according to the character of their utilisation, are entered in the following ways:

- to Profit and Loss account Utilization of funds up to the level of expenses spent on individual projects (centres) or operating activity in the respective accounting period;
- against a bank account in case of provision of financial means to projects of third parties that were collected within individual projects of the company.
